Customer shall not access any other Adair County database that is not authorized by this Agreement. Adair County reserves the right to immediately revoke access if Adair County believes that any unauthorized access has occurred. Adair County may revoke the access for as long as it deems necessary to compile an investigation of the unauthorized access.

Customer shall not, in whole or in part, sell, assign, sublease, extend, lend, borrow or in any way transfer customer's password(s) to another party.

Customer agrees to hold harmless and indemnify Adair County and its officials, officers, employees and volunteers for any claims or actions resulting from any inaccuracies in the data provided. Customer's sole remedy against Adair County and its officials, officers, employees and volunteers for any claims or actions resulting from any inaccuracies shall be the right to terminate this Agreement.

Customer agrees not to reproduce, in any form, any licensed or copyrighted material without the proper authorization from County.
